### Report from Harbormaster:

#### Tim Frame

- > Since last meeting the Michigan City Port Authority, have received Corp of Engineers permit to dredge the hoist well and the forklift well at Trail Creek.
- Previously the Michigan City Port Authority received their DNR permit and IDEM permit.
- > Colin from Edgewater Resources with be down later in the week to Finalize plans on what the Port Authority want to do there.
- Also, will be doing measurements in Washington Park on the Launch Ramp, because the North Lanes are completely choked off with sand. Will start the permit process for that.
- Big Boat race coming up August 5-7, 2022.
- Otherwise, things are pretty much normal
- Jumping ahead and mention the Cormorants in old business. Apparently one or two of them have come back. Found some droppings so we have found something to discourage them from being there. But in the meantime, we are just cleaning it up every morning. This is not as big a problem as last year. It seems the Cormorants come around the same time every year, possibly due to the type of fish that is available.
