I hereby agree, in the event a permit is issued to me, to abide by the rules and regulations of the Michigan City Port Authority (MCPA) governing the use of harbors, and also, to abide by all ordinances that govern the activities of the MCPA. I acknowledge that I have received, read, understand and will abide by the MCPA Rules & Regulations. The M.C.P.A. Rules & Regulations shall be deemed incorporated into this agreement in its entirety and shall be deemed a part of this agreement. I agree that the MCPA shall not be liable for any loss or damage, by theft or otherwise, to my boat or property while using the harbor or occupying any slip or space that may be allotted to me; and in consideration of the permit issued to me, I hereby release the MCPA of and from any claim by me for aforesaid loss, damage or theft. I authorize a representative of the MCPA to board my boat at all reasonable times for inspection to determine its seaworthiness, safety and compliance of all MCPA rules and regulations, including the prominent display of a proper decal and its compliance with the anti-pollution regulations.

The Michigan City Port Authority reserves the right to rent vacant slips on an annual basis to boat owners who have a boat smaller than the slip size, if the MCPA Board of Directors concludes the slip would otherwise go un-rented for the season. In the event that the M.C.P.A. is required to take legal action against me for violations of this agreement, including any violation of the Rules & Regulations, I agree to pay all costs incurred by the M.C.P.A. to enforce this agreement, including but not necessarily limited to court costs and attorney fees.

The above policies, rules and regulations are subject to change at the discretion of the Michigan City Port Authority Harbormaster and Board of Directors.
